ALBANIA:

Green light for migration deal with Rome.

Albania's constitutional court endorsed the agreement between the Albanian and Italian Governments allowing Italy to transfer asylum seekers to Albania. The deal was signed in November 2023 and faced opposition in Albania, resulting in temporary blocks and legal challenges based on concerns about constitutional rights and international law. According to the terms of this agreement, the Italian government will build two asylum centres near the north-western port of Shengjin, capable of processing annually 36,000 migrants. The centres will be funded by Italy and operate under Italian law, with Italian staff having certain legal immunities in Albania. The agreement now awaits ratification by the Albanian parliament. Italian parliament approved the agreement, and it is expected to pass in the Senate .
